PRIVACY STATEMENT

Introduction

Your privacy is vitally important to us. We will never sell, rent, lend or disclose your personal information to third parties without your absolute explicit consent.

This Privacy Policy focuses on describing the collection and subsequent use of your personal information. We believe you should know as much as possible about Sports League Software's practices, so that you can make informed decisions about your personal information.

The privacy practices of this statement apply to our services available under the domain of Sports League Software. By signing this document you agree to be bound by the terms and conditions of this Privacy Policy. By accepting the Privacy Policy and the Terms of Use in registration, you expressly consent to our use and disclosure of your personal information in accordance with this Privacy Policy. This Privacy Policy is incorporated into and subject to the terms described in the Sports League Software Terms of Use. This Privacy Policy is effective upon acceptance through the act of registration.

1. Information We Collect.

Our primary purpose in collecting personal information is to provide you with a high quality, useful and safe customized experience. This allows us to provide services and features that most likely meet your needs, and to customize our service to make your experience safer and easier. We only collect personal information about you that in our view is needed to achieve this objective.

2. Uses of Your Information.

As a matter of policy, we do not sell, rent, lend, or disclose any of your personal information to third parties without your explicit consent. However, the following describes some of the ways that your personal information may be used in the normal routine to provide our range of services to you.

Service Management. We use your personal information to provide the services you request. We use your personal information to: troubleshoot problems; measure consumer interest in our services, inform you about offers, products, services, and updates; customize your experience; detect and protect us against error, fraud and other criminal activity; enforce our Terms of Use; and as otherwise described to you at the time of collection.

You agree that we may use personal information about you to improve our marketing and promotional efforts, to analyze site usage, improve our content and product offerings, and customize the Site's content, layout, and services. These uses improve the Site and better tailor it to meet your needs, so as to provide you with a smooth, efficient, safe and customized experience while using the Site.

You agree that we may use your personal information to contact you and deliver information to you that, in some cases, are targeted to your interests, such as targeted banner advertisements, administrative notices, product offerings, and communications relevant to your use of the Site. By accepting the Terms of Use and Privacy Policy, you expressly agree to receive this information. You may make changes to your email notification preferences at any time.

Internal Service Providers for Our Operations. We may use third parties that we refer to as internal service providers to facilitate or outsource one or more aspects of the business, product and service operations that we provide to you (e.g., search technology, email support) and therefore we may provide some of your personal information directly to these internal service providers. These internal service providers' are subject to confidentiality agreements with us and other legal restrictions that prohibit their use of the information we provide them for any other purpose except to facilitate the specific outsourced Sports League Software related operation, unless you have explicitly agreed or given your prior permission to them for additional uses. We do not share credit card information with such third parties.

In some instances, the internal service provider may collect information directly from you (such as for Sports League Software surveys). In these cases, you will be notified of the involvement of the internal service provider, and all additional information you provide them and their additional uses will be strictly up to you. If you provide additional information to an internal service provider directly, then their use of your personal information is governed by their applicable privacy policy.

Events. Sports League Software cooperates with law enforcement inquiries, as well as other third parties to enforce laws, such as: intellectual property rights, fraud and other rights, to help protect you and the Sports League Software service. Therefore, in response to a genuine request by law enforcement or other government officials relating to a criminal investigation or alleged illegal activity, we may disclose personal information about you.

Third parties may unlawfully intercept or access transmissions or private communications, or users may abuse or misuse your personal information that they collect from the Site. Therefore, although we use industry standard practices to protect your privacy, we do not promise, and you should not expect, that your personal information or private communications would always remain private.

3. Use of Client Database Information.

As a matter of policy, we do not view, access, sell, rent, lend, or disclose any of member database information. However, from time to time it may be necessary for Sports League Software Support staff to access member's databases in a support function only. This access will only occur with direct consent of said member.

4. Email Address Privacy.

We do not sell, rent, lend, or disclose email addresses for any other purpose than in direct association with your use of the Sports League Software service.

5. Password Protected Access

You are responsible for all actions taken with your User ID and password. Therefore we do not recommend that you disclose your Sports League Software password to any third parties. If you lose control of your password, you may lose substantial control over your personal information. For this reason, if you know your password has been disclosed to a third party, you are strongly advised to immediately change your password.

6. Accessing, Changing and Removing Your Personal Information.

We offer you the ability to review and change the information you manually provide to us by signing-into the Site and entering in your new information. You must promptly update your personal information if it changes or is inaccurate. Once posted, in some cases you may not be able to change or remove a public posting made on the Site.

At your request, Sports League Software will deactivate your account and associated information from the active database. To make this request, just simply email support@SportsLeagueSoftware.com and request removal from the directory. Information will be deactivated as soon as reasonably possible. We will retain in our files some personal information to prevent fraud, resolve disputes, troubleshoot problems, assist with any investigations, enforce our Terms of Use and comply with legal requirements as is permitted by law.

Therefore, you should not expect that all of your personal information would be completely removed from our databases in response to your requests. However, such personal information will be deactivated from member viewing and will only be available to selected Sports League Software staff if needed.

7. Security.

Your information is stored on secure Site servers. They use safeguards to protect your personal information against loss or theft, as well as unauthorized access and disclosure to protect your privacy, including 'firewalls' and Secure Socket Layers. We treat data as an asset that must be protected against loss and unauthorized access.

8. Links

Our web sites contain links to other sites. Sports League Software is not responsible for the privacy practices or content of such other sites. We encourage our users to be aware when they leave our site and to read the privacy statements of each web site to which we may link that may collect personally identifiable information.

9. Notice.

We may amend this Privacy Policy at any time by posting the amend terms on the Site. All amended terms shall automatically be effective immediately after posting on the Site. We will notify you in accordance with your Notification Preferences.
